## Information leaflet on visas and residence permits

- Stand 07/2021 -

### General information:

Lithuanian citizens are subject to the free movement of persons within the European Union. Visas or resident permits are not needed any more. For longer-period stays in Germany European Union citizens have to register at the competent registry office (Einwohnermeldeamt) in Germany.

Citizens of Non-EU-Countries, living with a valid permanent residence permit or a category "D" visa in Lithuania can travel to Germany for visiting/business purposes for 90 days within 6 months without another visa.

To stay in Germany for more than 90 days within 6 months and / or working purposes it is not necessary to apply for a visa in advance, if the foreigner has one of the following Lithuanian residence permits:

- residence permit for family members of EU Member States' nationals – card acc. to Art. 10 sec. 1 Directive 2004/38/EC: „Europos Sąjungos valstybės narės piliečio šeimos nario leidimas gyventi Lietuvos Respublikoje“, provided that the family member accompanies the EU Member States' national or moves to him to establish a joint residence
- “long-term resident – EC” acc. to Council Directive 2003/109/EC: „ilgalaikis gyventojas – EB“, provided that all stipulations of Art. 14 ff. of the Council Directive 2003/109/EC are fulfilled

In any other case an application for a residence permit has to be filed in the German Embassy in advance.

**Application:**

Application can be filed during the opening hours of the Embassy (see below), an appointment is needed: [https://service2.diplo.de/rktermin/extern/choose\\_realmList.do?locationCode=wiln&request\\_locale=de](https://service2.diplo.de/rktermin/extern/choose_realmList.do?locationCode=wiln&request_locale=de). Applications must be filed personally.

**Duration:**

Visa for the purpose of studying can usually be issued within 4 weeks. For other kinds of visa a processing time of up to a few months has to be calculated. Please consider this while planning your stay and application.

**Necessary documents:**

- two filled in and signed application forms
- valid passport (valid for at least six more months)
- residence permit for Lithuania (valid for at least three more months)
- 2 biometric passport photographs
- visa fee of 75 €
- health insurance (can be presented when picking up the visa)
- further documents depending on the purpose of stay (see below and next page)

**All documents have to be presented in original version together with two simple copies.** Documents which are not in German or English have to be presented with a certified translation by a notary.
